# RE: 2013-2014 Annual Membership Fees, Financial Responsibility Disclosure (FRD) and IOLTA Reporting Requirements

Effective with the reporting year 2013-14, The West Virginia State Bar is going to online payment of fees and reporting of FRD and IOLTA information. Assistance in completing the forms online can be obtained by contacting Mike Mellace (304-5537223 or mellacem@wvbar.org) at the Bar. Since September 1, 2013, falls on a Sunday and September 2, 2013 is Labor Day, effective at midnight on <u>September 3, 2013</u> an <u>automatic and separate \$25.00 late penalty assessment for **both** late payment of fees and submission of FRD reports will be added.</u>

If you are not quite ready to use on-line reporting, you may still pay your fees and report by paper, however, there is a \$10.00 processing fee assessed. If you choose to report by paper, enclosed you will find appropriate forms. The forms must be returned to The State Bar, Attention Membership, 2000 Deitrick Boulevard, Charleston, WV 25311. The envelope containing the forms must be <u>postmarked no later than **September 3, 2013**. Since September 1, 2013, falls on a Sunday and September 2, 2013, is Labor Day, Members whose forms are postmarked after September 3, 2013, will be subject to an <u>automatic and separate \$25.00 late penalty assessment for **both** fees and FRD reporting. Failure to comply with payment of fees and FRD reporting will result in an automatic suspension from active membership in The State Bar. While there is no requirement for West Virginia lawyers to have professional liability insurance, there is a requirement to disclose whether or not you have insurance. Your Financial Responsibility Disclosure information is made available to the public both on the website and by calling The State Bar offices. NOTE: Members who are on "inactive" or "active but not practicing" status, do not have to comply with the mandatory FRD and IOLTA reporting requirements.

Beginning with fiscal year 2012-13, members are required to do IOLTA Reporting. This reporting will make the collection of IOLTA information easier and more accurate. Any questions regarding your IOLTA Reporting should be directed to Anita Casey.

Since September 1, 2013, falls on a Sunday and September 2, 2013, is Labor Day, your notice must be postmarked by <u>September 3, 2013</u>. If your notice is not postmarked on or before September 3, a **\$25 late filing fee** will attach to your account. Failure to comply with this Notice will result in an automatic suspension from active membership in the State Bar. In addition to the **\$25.00 penalty** authorized by Article III (A) Section 4, a penalty of **\$75.00 shall be added to the fees owed by all members who are suspended for the financial responsibility disclosure non-compliance.**
